Education and Networking Sessions Explode

ASSP Long Beach members have sent a clear message recently—they want to participate again! That's music to the ears of the Executive Committee who kicked off the 23-24 term (1 July 2023 -30 June 2024) by vastly overhauling the program.

Some of the many improvements to the monthly sessions include:

All Education and Networking Sessions (formerly known as "technical sessions") now earn CEUs! The Long Beach Chapter has applied to ASSP for the awarding of CEUs for each session in the 23-24 term. Following each session, attendees are provided with a code which enables them to go on-line to the ASSP site to claim their CEUs.

Sessions are all held at the same time and same place every month—no need to wonder where the next one will be! All sessions begin at Noon at CSUDH. Presentations begin at 12:15 and generally run until 1:15, leaving 15 minutes for questions and discussion.

The sessions are now offered in both formats: in-person and virtually. We'd love to see everyone out and inperson, but we know that it isn't always possible. So,



members who cannot make it to CSUDH are invited to attend virtually via Zoom. Everyone who registers is emailed a Zoom link prior to the session. Those who attend virtually are also eligible for CEUs.

Lunch is provided by the Long Beach Chapter. You can't come for a lunch-time education and networking event and not eat, right? The Chapter is providing a complimentary lunch from Jimmy John's (sandwich, chips, and a drink) to everyone who attends in person.

So far, registration for the Education and Networking Sessions for the 23-24 term have been record-setting. For our July session, the presentation was made by Ms. Allyson Clark on It's Getting Hot in Here – Heat Illness Standard. 35 members registered for the event, and the evaluations were phenomenal.

In August, our very own Vice-President/President-Elect,
Luis Ortiz was the presenter.
Luis gave his incredible
presentation on "Safety
Management vs Safety Hero," and a whopping 66
members registered. Once
again, the reviews were
awesome.

In September, Chapter President Chris Rainwater presented on "From Safety Police to Safety Culture: The Transformation of Effective Safety Management." 68 members registered for the event—43% of our Chapter membership!

What's next? The October Education and Networking Session will be presented by none other than Dick Monod de Froideville. Dick will present on the Cal/OSHA Appeals' Process. Grant and Scholarship Opportunities

At its meeting in July 2023, the Executive Committee (EC) approved a significant increase to the Long Beach Chapter's Grants and Scholarships program. The program is designed to assist any ASSP member with funding for a number of educational opportunities related to safety and occupational health. The specific grants and scholarships include the following:

- The Long Beach ASSP/CSUDH Scholarship. This \$750 scholarship is matched by CSUDH to pay for safety-related classes taken at CSUDH.
- Long Beach ASSP/Private Sector Education Grant. This \$1500 grant is for safety-related classes, continuing education, or certifications.
- Long Beach ASSP/Private Sector ASP/ CSP Certification Grant. These \$500 grants (two awarded annually) are for application fees and testing for the ASP/CSP.
- Long Beach ASSP/Private Sector Bachelor's Degree Scholarship. This \$2,000 scholarship is to support pursuit of a Bachelor's degree within the safety field.
- Long Beach ASSP/Private Sector Master's Degree Scholarship. This \$2,000 scholarship is to support pursuit of a Master's degree within the safety field.
- Long Beach ASSP/Private Sector ASSP Conference Grant. This \$1,000 grant will assist with registration, travel, and lodging for an annual ASSP conference/ education event.

Any member of the Chapter in good standing may apply for these grants and scholar-ships. Generally, members will submit an

essay of at least 1,000 words on the importance of higher education within the safety field, certifications, or attendance at a conference (depending on the grant/scholarship sought).

The window for submitting essays is July 1 - September 30th of each year.

Scholarship Selection: All essays will be submitted to the Grants and Scholarships Chair. The essays will be reviewed and ranked by the Chair, and recommendations for selection will be provided to the EC. The EC will select a single recipient for each grant and scholarship to be awarded by November 1st of each year.

Essay Tips

Good essays require planning, thought, and motivation. When writing an essay to compete for a grant or scholarship, consider:

- Why is this educational pursuit important to me?
- How will this grant/scholarship help me to improve the field of safety and occupational health?

Also, remember these tips:

- Grammar counts! In any essay, be sure to avoid common grammatical and spelling errors.
- A strong and compelling introduction is always helpful.
- Be clear about where you are in your career and where you want to go.

The 2023 Safety Professional of the Year Award (SPY)


